**Excellence**

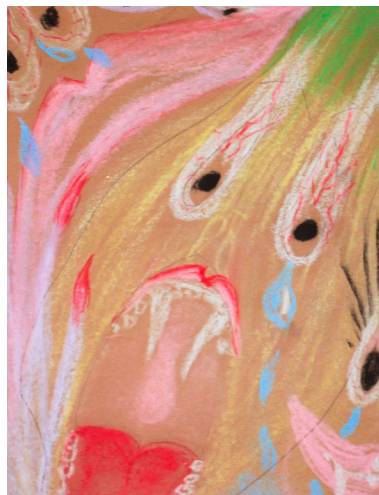
*By this we mean...*

- Provides education and increased awareness with respect to substance abuse and dependency

### Drug-Free Workplace Services

- Helps employers achieve long-range safety and cost-saving benefits

### Family Program

- Open to spouses, partners, parents, siblings and other relatives and friends

### Outpatient Treatment Services

- Assessments and Drug Testing
- Individual and group counseling

### Problem Gambling Services

### Ambulatory Detox

- Non-narcotic management of opiate withdrawal

- Program in collaboration with Catholic Charities to help underserved Hispanic community







## Accomplishments & Outcomes

During FY17, 59% of women and 57% of men completed residential treatment and met all of the treatment milestones, exceeding the national average of 40-44%

One year after completing residential treatment, 55% of women and 50% of men were still sober and reported an improved quality of life (For those residents completing treatment in FY16)

In outpatient treatment, 80% of clients admitted to service met or partially met their treatment plan goals during treatment.

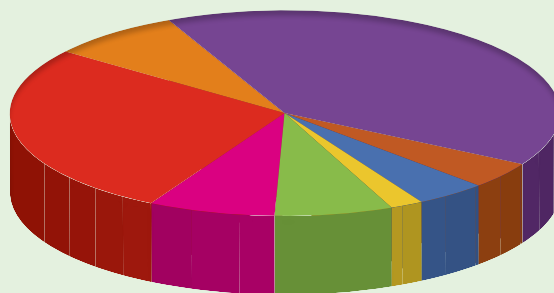
We welcomed the 14th drug-free baby born to residents at Oak House and Nevaeh Ridge

Implemented three new forensic programs to assist those in recovery from opiate addiction and involved in the criminal justice system

Purchased 9075 Mentor Ave to be remodeled and connected to the current Mentor office creating 3,751ft<sup>2</sup> of additional office space including a large conference room

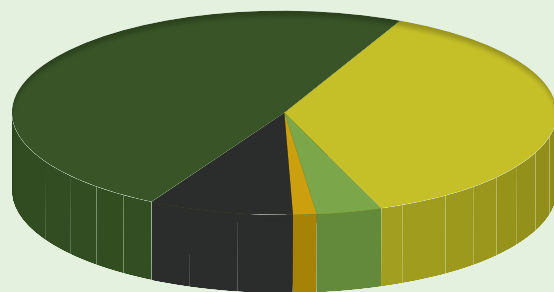
Opened Bill Horvath House, a men's Recovery House in Painesville and Nowlen Manor, a women's Recovery House in Mentor
